



Application of the Frontier Closed Area (FCA) Permit

Further to the Permit Office's new policy for applying or renewal of "Frontier Closed Area (FCA) Permits", all applicants must now sign a "Personal Data Declaration". As usual, WWF will help to apply for permits on your behalf but please, first send the following documents by mail to the Mai Po Administration Officer, address: Mai Po Nature Reserve, San Tin, Yuen Long, N.T., Hong Kong.

(A) To apply for new FCA Permits, please send the following items:

1. Photocopy of H.K.I.D. card or passport;
2. Photocopy of Hong Kong Bird Watching Society Membership receipt;
3. Photocopy of WWF Hong Kong Membership Card;
4. Photocopy of "Mai Po Marshes Entry Permit" (issued by the Agriculture, Fisheries & Conservation Department) &
5. Signed original copy of the attached "Personal Data Declaration"

Remarks: All FCA Permits will be expired on 4th March every year.

(B) To renew FCA Permits, please send us photocopies of the following:

1. Photocopy of H.K.I.D. card or passport;
2. Photocopy of Hong Kong Bird Watching Society Membership receipt;
3. Photocopy of WWF Hong Kong Membership Card;
4. Photocopy of "Mai Po Marshes Entry Permit" (issued by the Agriculture, Fisheries & Conservation Department) &
5. Signed original copy of the attached "Personal Data Declaration"

Remarks: All FCA Permits will be expired on 4th March every year and;
Send us photocopies of the above documents before 31st December every year for the renewal process.
